The ACCA syllabus is broken down into two levels; the Knowledge and Skills modules make up the Fundamental Level and Essentials and Options modules make up the Professional Level. There are 15 exams in the entire syllabus, to gain the ACCA qualification you have to pass 13 of these exams.
